"DIRECTIVE"


Whereas, a request has been received from the Chairman, The Bilaspur District Co-operative Marketing & Consumer Federation Ltd. Bilaspur, District Bilaspur through Deputy Registrar, Cooperative Societies Central Division Mandi vide letter dated 31.3.2021, that TA/DA rates allowed to the Board of Directors of the federation are very meager and inadequate in the present scenario since the existing rates were approved vide this office letter dated 10.02.2012.

Whereas, the request of the said District Cooperative Marketing & Consumer Federation has been examined in this office in detail vis-a vis the financial position of said federation and it is observed that the federation has earned profit during the year.

Presently, the federation is paying Rs. 200/- as sitting fee and Rs.200/- as D.A to the Chairman and members of the BOD and Rs. 5/- Per K.M for performing journey by own car as allowed vide Directive of even number dated 10.02.2012.

Whereas, after due consideration of the matter in view of the financial position of the federation, the request of the said Federation and recommendation of the Deputy Registrar Cooperative Societies, Mandi it is deemed fit to revise the existing rates of Sitting fees/DA in respect of the members of the Board of Directors of the Bilaspur District Co-op. Marketing & Consumer Federation as under with immediate effect:-


