OFFICE ORDER

Whereas, Assistant Registrar, Cooperative Societies Keylong, Distt. Lahoul & Spiti, HP has submitted request vide letter dated 09.03.2021 regarding the transfer of administrative control for the regulations of the Lahoul Potato Growers Co-op Marketing cum Processing Society Ltd. ( Primary Cooperative Society) from Assistant Registrar, Cooperative Societies Kullu to Assistant Registrar, Cooperative Societies Keylong.

Whereas, the Lahoul Valley Agro Producer Coop. Marketing and Processing society Ltd has been registered by the Assistant Registrar Cooperative Societies Keylong, Distt. Lahoul & Spiti and the society open its office at Manali and factory at Shamshi in Kullu. As the office and factory of the society is located in Kullu, it is not possible to Assistant Registrar, Cooperative Societies Keylong to have a administrative control over the Society from Keylong and this office vide letter dated 24.12.1988 had accord approval/ permission to transfer the administrative control to Assistant Registrar, Cooperative Societies Kullu, Distt. Kullu.

Whereas, Managing Committee of the Lahoul Potato Growers Co-op. Marketing cum processing Society Ltd. Manali, Distt. Kullu has resolved vide resolution no 07, dated 29.7.2021 to transfer the over all administrative control of LPS to Assistant Registrar, Cooperative Societies Lahoul & Spiti.

Whereas, Assistant Registrar, Cooperative Societies Kullu, Distt. Kullu has submitted request vide letter dated 17.10.2020 regarding entrusting the complete control of LPS from the O/o Assistant Registrar, Cooperative Societies Kullu, Distt. Kullu to the O/o Assistant Registrar, Cooperative Societies Keylong as the Atal Tunnel has now been opened for traffic throughout the year.

Whereas, meeting/ general house of the said society is also being organized/ held at Lahoul and as far as the matter of property of said society is concerned, a cooperative society can purchase/ acquired property any where in the State of Himachal Pradesh subject to the approval of competent authorities.

Now therefore, after consideration/examination of the request submitted by the Assistant Registrar, Cooperative Societies Keylong, resolution passed by the Managing Committee of LPS, as well as the request of Assistant Registrar, Cooperative Societies Kullu, Distt. Kullu in this behalf and keeping in view of the road connectivity to Keylong with the opening of Atal Tunnel throughout the year, overall administrative control for regulating the Lahoul Potato Growers Co-op Marketing cum processing Society Ltd. Tandi , Distt. Lahoul & Spiti is entrusted / transferred to Assistant Registrar Cooperative Societies Keylong, Distt. Lahoul & Spiti, HP in suppression of this department letter dated 24.12.1988.
