Amalgamation:	(a)	Scrutiny of proposal and communication of deficiencies/discrepancies-7 days.
	(b)	Issuance of order of amalgamation within 30 days after affording opportunity of being heard to the concerned
Statutory Inquiry:	(a)	Under section-67 of Himachal Pradesh Cooperative Societies Act, 1968- within two months of the issuance of the order of inquiry.
	(b)	Further action on the inquiry report by the concerned authority- within one month.
Audit:		Audit to be completed within- 3 months from the date of allotment to an auditor
Audit compliance:		Audit compliance to be ensured by the concerned society – within 3 months from the receipt of audit report/objections therein.
Arbitration:		Arbitrator to decide the dispute – within 4 months after receipt of the dispute/ reference from parties/ competent authority.
Liquidation:		Liquidator to pass liquidation order- within statutory period of 5 years , however, the liquidator to ensure liquidation proceedings/ finalization preferably in two years.
Appeals/Revision:		Appellate/ Rivisional authority to dispose of an appeal/revision - within 4 months .
. Inspection:		The inspection of a society to be completed –within one month of its allotment by the concerned officer/ official.
. Elections:		Elections to be conducted by management before its expiry of tenure, failing which department to ensure conduct of election – within 6 months of expiry of tenure
. Supersession/ appointment of Administrator:		within- one month from the receipt of complete case after affording opportunity of being heard by the competent authority.
