Subject: Norms for providing working capital subsidy to all kinds of SC Cooperatives under Scheduled Caste Development Programme.

Sir,

I am directed to refer to your letter No. 1-6/97-Coop.(P&D)-II dated 08th February, 2022 on the subject cited above and to convey the approval of the State Government for revised norms as under:-

Sr. No.	Name of Plan	Existing Norms	Proposed Norms
1.	Tribal Area Development	The working capital subsidy will be admissible only to societies which are eligible for assistance under TSP will be subject to a maximum of share capital contribution paid during the previous year by the members or Rs. 1,00,000/- whichever is less.	The working capital subsidy under SCDP and TADP shall be provided upto a maximum of Rs. 1.00 lac only to those cooperative societies which are earning profit for the preceding three years subject to availability of budget under the scheme.
2.	Scheduled Caste Development Programme	i). that the business turnover of the society for last three years should be increased by 10% ii). The society should have net profit for the last three years. iii). The working capital of the society should have been increased by 5%.
