Filling up of 45 posts of Peons in the Department of Cooperation

The Department had advertised 45 posts of Peons (Class-IV) in leading newspapers on 02-12-2016 which were to be filled in through viva-voce as per the R&P Rules in vogue. The Govt. of H.P. vide Notification No. Per (AP.B)B(15)-5/14 dated 17-04-2017 and 25-04-2017 has decided that in class-III and IV posts where provision of interview exists, shall be made on the basis of merit of written examination or prescribed educational qualification followed by evaluation, by verifying the original documents/credentials only based on the parameters devised in the notification of even number dated 17-04-2017, which reproduced as under.

	Written Test	For Class-IV posts
i)	Weightage for the minimum educational qualification as the Recruitment & Promotion Rules. (Percentage of marks obtained in the educational qualification would be multiplied by 0.025. For example, an individual has secured 50% marks in the required educational qualification he/she will be allowed 1.25. marks($50 \times 0.025 = 1.25$)	Percentage of marks obtained in qualifying examination to be calculated out of 85. For example a candidate getting 50% marks in Matric will be given 42.5.
ii)	Belonging to notified Backward Area or Panchayat, as the case may be	1(one)
iii)	Landless family/family having landless that 1 Hectare to be certified concerned Revenue Authority.	2(Two)
iv)	Non-employment certificate to the effect that none of the family members is in Govt./Semi Govt.	2.5(Two & a half)
v)	Differently abled persons with more than 40% impairment/disability/infirmity	1(one)
vi)	NSS(atleast one year)certificate holders in NCC/The Bharat Scout and Guide winner in National level sports competition.	1(one)
vii)	BPL family having family annual income (from all sources) below 40,000 or as prescribed by the Government from time to time.	2.5(Two & a half)
viii)	Widow/divorced/destitute/single women	1.5(One & half)

ix)	Single daughter/Orphan	1(one)
x)	Training of atleast 6 months duration related to the post applied for from a recognized University/Institution.	-----
xi)	Experience upto a maximum of 5 years in Govt./semi-Govt. organisation relating to the post of applied for(0.5 mark only for each completed year).	2.5 (two & a Half)
	Pro-rata weightage for more/less than 15% interviews marks at present will be given accordingly.	

All the candidates who have applied for the post of Peon in response to the advertisement dated 02-12-2016 are hereby informed that no interview shall be conducted and the above mentioned posts shall be filled up on the basis of the parameters devised vide notification dated 17-04-2017.

The Department has fixed the dates for evaluation of candidates as per the parameters elaborated above w.e.f. 22-05-2017 to 29-05-2017 for which call letters are being sent separately. The candidates are further advised to get prepare relevant documents/certificates (mentioned at Sr. No.I to XI above, whichever is applicable to them) from the competent Authority and to appear before the Selecting Board on the scheduled date, time and venue along with original documents/testimonials/Educational certificates and one set of attested copies of all documents.
