In supersession of the previous notification issued by this department and in exercise of the powers conferred under section 3 of the Himachal Pradesh Societies Registration Act, 2006 (Act No.25 of 2006) the Governor, Himachal Pradesh, is pleased to appoint Registrar Cooperative Societies, Himachal Pradesh, as "REGISTRAR", all the District Magistrates in Himachal Pradesh as "ADDITIONAL REGISTRARS" and all the Sub-Divisional Magistrates in Himachal Pradesh as "DEPUTY REGISTRARS", for the purpose of this Act and shall exercise powers and perform duties of REGISTRAR under all provisions of this act in the areas specified as under in public interest from the date of publication of this notification in Rajpatra Himachal Pradesh: -

Name	Area/jurisdiction	Nature of Society
Registrar	Within the geographical limit of State of Himachal Pradesh.	Societies having area of operation over more than one district or entire State
Additional Registrars	Within respective jurisdiction of District Magistrates i.e. district level.	Societies having area of operation confined to a district.
Deputy Registrars	Within respective jurisdiction of Sub-Divisional Magistrates i.e. Sub-Division level.	Societies having area of operation within Sub-Divisions.


