"DIRECTIVE"


Whereas, a request has been received from the Secretary Shimla Tehsil Co-op Marketing & Consumer Union Ltd. Dhalli Tehsil and District Shimla and the Solan Tehsil Co-op Marketing & Consumer Union Ltd. Ganj Bazar Solan Tehsil and District Solan that TA/DA rates allowed to the Board of Directors of the Union are very meagre and inadequate in the present scenario since the rates were approved eighteen years back.

Whereas, the request has been examined in detail vis-a vis the financial position of said Union and it is observed that the Unions are earning profit and the financial position is satisfactory.

Presently, the Unions are paying Rs. 125/- as sitting fee and Rs.80/- as D.A to the Chairman and members of the BOD and @Rs. 3.50/- Per K.M for performing journey by own car as allowed vide Directive of even number dated 27-08-2002.

And whereas, in view of the financial position of the aforesaid Tehsil Unions the request in respect of the Sitting Fees, Daily Allowance for the Chairman and members of the BOD is hereby fixed/allowed as under with immediate effect:-
