Subject:- Regarding enhancement of Sitting Fees and Daily Allowance of the Managing Committee members of the PACS and Non-Agriculture-Cooperative Societies.

Whereas, the matter regarding revision of Sitting Fees and Daily Allowance etc. in respect of the Managing Committee members of the PACS and Non-Agriculture Cooperative Societies was under consideration of the department for quite some time.

Whereas, after due consideration of the matter and keeping in view the rate of inflation and other determinants, it is deemed fit to revise existing rate of Sitting Fee and Daily Allowance etc. in respect of the Managing Committee members of the PACS and Non-Agriculture-Cooperative Societies.

Therefore, in supersession of all previous Directive/Instructions /Orders passed on the subject and in pursuance of rule-152 of the H.P. Cooperative Societies Rules, 1971 following rates of Sitting Fee and Daily Allowance etc. in respect of the Managing Committee members of the PACS and Non-Agriculture-Cooperative Societies is fixed as under in order to ensure smooth functioning of the institution with immediate effect. However, other facilities provided vide order of even no. dated 27-02-2002 shall remain unchanged.
