Subject- Regarding creation and sanction of posts of Junior Office Assistant (IT) in each office of the Department.

Sir,

On the subject cited above, it is intimated that the Administrative Department vide letter No. Coop.D(2)-2/2015 dated 07-08-2020 and another letter No.Coop.B(2)-2/2014 dated 23-09-2020 had conveyed the approval of the Government for creation of 02 posts and 50 posts of Clerks of Junior Office Assistant (IT) by abolishing 02+50= 52 posts of Clerks and to fill the posts of Junior Office Assistants (IT) on contract basis.

Subsequently, after completion of codal formalities for bifurcation of newly created 52 posts of Junior Office Assistant (IT) and to abolish equal number posts of Clerks at Directorate level and in the field office the detail proposal was sent to the Government for approval vide this office letter of even No. dated 30-07-2021.

The Government of Himachal Pradesh has acceded to the aforesaid proposal of the Department vide letter No. COP-B002/10/2021-Co.op -HP.Secretariat dated 24-09-2021.Copy of letter No. 4-37/2016-Coop.(Estt) dated 30-07-2021 and approval of the Government conveyed vide letter No. COP-B002/10/2021-Co.op -HP.Secretariat dated 24-09-2021 are available on the Departmental website i.e. coophp.nic.in for ready reference.
